Narrative needs additional information, such as specific examples of how the volunteer stood out and/or more detail about how or why there was a significant/impactful outcome	2-3	
Narrative has missing information and does not indicate how the volunteer stood out and/or did not indicate any significant/impactful outcome	0-1

 Taking initiative and making improvements – Did the nominee: Contribute ideas and suggestions to the campaign? Lead or co-lead campaign events and/or projects? Participate and contribute meaningfully to all or most events during the campaign? Recruit new committee members or volunteers? Bring in more donations or contributions to the campaign? 	5	
 Motivate and inspire others – does the nominee: Encourage others to participate in the campaign or events? Have a positive and excited attitude about the campaign and events? Have a strong presence during the campaign? Thank volunteers and staff for participating and/or contributing to the campaign and events? 	5	
 Educating self and others – does the nominee: Train or mentor new committee members or volunteers? Answer questions about the CFD and explain campaigns for events? Share information about and promote the CFD (signs/posters, email, word of mouth) with other staff? Develop new and innovative ways to communicate information about the CFD/charities/campaign? Share campaign successes? 	5
